Activity Bus Transportation Form

An Activity Bus will be provided to students who are actively participating in Berkshire extra-curricular activities. The District will provide transportation from Berkshire Jr./Sr. High School to Ledgemont Elementary during the fall, winter and spring sports seasons. Transportation will offer a daily one-trip bus ride when school is in session. The bus will leave Berkshire Jr./Sr. High School at 6:15 p.m., Monday through Friday, and will arrive at Ledgemont Elementary at approximately 6:40 p.m. (time may vary depending on weather conditions). This form **must** be completed and on file with the transportation office in order for student(s) to ride on the Activity Bus.

Please note: Parent/guardian's are responsible for the safety of their student(s) once they depart from the bus at Ledgemont Elementary. It will be the parent/guardian's responsibility to have arrangements in place for their child(ren)'s transportation home. If it is noted by the bus driver that a student is left unattended at least two times, the parent/guardian(s) may be required to make other accommodations for their student(s) transportation from Berkshire Jr./Sr. High School.
