School facilities may be used by members of the community groups at times when school is not in session, or when the activity will not interfere with scheduled activities of the school. Charges for school facilities cover costs incurred by the Board of Education such as custodial costs, heating and lighting. Whenever the building is utilized by a community group, an employee must be present. Exceptions to this rule may be made with the Superintendent. If the building is used when a custodian is on duty, there may be a minimal cost for a final cleanup.

If the building is used at times when schools are not open for school purposes, the contracting group shall be responsible for paying all custodial costs, including overtime costs, which calculates to be **\$34.33 per hour**.

The Superintendent is authorized to waive this fee for community student groups and those groups who contribute regularly to the general welfare of academic or athletic programs for the Berkshire Schools. For long term or regular use, the principal and superintendent shall be authorized to negotiate appropriate contracts which will not result in any cost to the Board.

A School employee must be present if the kitchen equipment is used.

SMOKING: Smoking is not permitted on the grounds or in any district building at any time.
